



Couples Package Terms & Conditions

The Couples Package includes a 4-night minimum stay at the Atrium Spa and Resort (the "Resort"), Aqua Mania excursion, \$100 Greenhouse gift card, and a couple's Swedish massage with coupon code **COUPLES22**. Valid on stay dates August 21, 2022, now until November 18, 2022. Valid on a one-bedroom unit only. The coupon expires on September 30, 2022. Verifiable retail pricing of the Couples Package is \$1,200.

The Couples Package is available to individuals over the age of 21 who can travel into St. Maarten (ie. Travelers must have valid passports (or other required documentation) to enter the destination country). The package cannot be combined with other promotions or discounts. Unless otherwise stated herein, the Couples Package does not include transportation or meals. Accommodations at the Resort is for a maximum of 4 adults in a one-bedroom unit. Room locations are on a request-only basis and subject to availability. Gratuities, a \$200 refundable security deposit, resort fees, taxes, laundry, telephone calls, other excursions, or any other incidentals at the Resort are the responsibility of the guest. Reservations for accommodations at the Resort will be made at the time of booking the Couples Package.

Reservations for the Aqua Mania excursion can be made by calling 1-888-992-8748 or sending a reservation request to info@stmaarten-activities.com. Aqua Mania excursion is limited to pre-determined days of the week, based on excursion type and the package does not include optional gratuity.

A \$100 Greenhouse gift card will be provided at the time of check-in. Guests must be of legal drinking age to consume alcoholic beverages. Reservations are not required, and the \$100 gift card is valid on any night during your reservation dates. Gratuity is not included. Please disclose any dietary needs or restrictions to the restaurant.

The package includes a couple's Swedish massage provided by Aquarius Spa (the "Spa"). The Spa is located on the main floor of the Atrium. Reservations are required in advance to guarantee redemption. Full refunds for will be provided if the Couples Package is cancelled more than thirty days prior to the guests' travel dates. No refund will be provided for cancellations made within thirty days of the guests' travel dates.

These Terms and Conditions are subject to the laws of the state of Florida, and the United States. Any dispute arising from these packages shall be litigated only in the courts of Orange County, Florida, which shall have exclusive jurisdiction.

YOU MAY ALSO CANCEL THIS CONTRACT IF ACCOMMODATIONS OR FACILITIES ARE NOT AVAILABLE PURSUANT TO A REQUEST FOR USE AS PROVIDED IN THE CONTRACT.

TO CANCEL THIS AGREEMENT, A SIGNED AND DATED COPY OF A STATEMENT THAT YOU ARE CANCELING THE AGREEMENT SHOULD BE MAILED AND POSTMARKED, OR DELIVERED TO LATOUR HOTELS AND RESORTS, INC. AT 1 VANCE GAP ROAD, ASHEVILLE, NC 28805 NO LATER THAN MIDNIGHT ON THE DATE 30 DAYS FROM THE DATE ISSUED ON THIS CERTIFICATE.

NO PURCHASER SHOULD RELY UPON REPRESENTATIONS OTHER THAN THOSE INCLUDED IN THIS CONTRACT.

Washington Required Disclosure.
